Nichols Pool Service (NPS) of Feasterville-Trevose, PA agrees to service the swimming pool for the above named owner at the address indicated above, who in turn agrees to payment terms outlined below for the services provided as agreed upon in this signed contract.

**NPS shall perform the following for FULL SERVICE PACKAGES:**

- standard Spring pool opening (including opening chemicals)
- test pool water for chlorine and alkaline (pH) residuals each visit and treat pool as needed
- test salt levels and add if needed
- skim water surface to remove floating debris
- check filter pressure / clean and backwash if necessary
- vacuum pool weekly, with OUR vacuum system, not your plumbing (NOTE: initial vacuuming may not be done at opening)
- clean out pool cleaner and check operation
- clean all strainer baskets (pumps, skimmers, etc.)
- introduce chemicals to balance pH, alkalinity, and shock treat pool weekly (if needed)
- provide service report after each visit (written or via email)
- extra charges for additional chemicals and parts required beyond normal pool conditions, will be billed to above customer
- standard Fall pool closing (including closing chemical kit)

TERMS:

- 1. In the event of severe weather, the pool will be cleaned as quickly as our schedule allows.
2. NPS shall not be responsible for any damage to the pool, its deck or any other related parts due to hydrostatic water pressure that may occur during the emptying of the pool for cleaning, painting, or repairing or while the pool is left empty or filling.
3. NPS will not be responsible for damage to lawns or landscaping due to water discharging while emptying the pool for repairing, cleaning, painting, backwashing, or cleaning the filter system.
4. NPS will not be responsible for any damage to lawn or landscaping due to the removal and drying of the pool cover.
5. Pool covers that require removal of leaves/debris and/or pumping of excessive water before cover can be removed, will be billed at an additional \$100.00 per hour.
6. NPS will not be held responsible for tears in any covers due to any damage the cover may have sustained over the winter or if the cover is beyond its useful life.
7. The owner named above where pool is located is responsible for ensuring the filter timer is functioning properly (filter goes on and off each day) and maintaining a satisfactory chlorine/salt level, between weekly vacuum visits.
8. NPS will not cover costs to repair pumps, filters, heaters, timers, air blowers, chemical feeders, cleaners, salt generators, spas, plumbing, and controls. Any repairs made will be an additional charge and billed upon completion of service.
9. Payments via personal check will only be accepted for full pre-payment. All other balances will be charged to the credit card on file at the agreed upon payment schedule.
10. Pool Owner is responsible for contacting NPS if pool is not operating normally.
11. If contract is cancelled or in default, prior to its anniversary date, all work performed to date will be recalculated at per service call rates. PLEASE NOTE: Any contract over 10 (ten) days past due, shall be subject to immediate termination and subject cancellation of contract and forfeit of pool services.
